ARIZONA CORPORATION COMMISSIONER JIM O'CONNOR ENDORSES STEVE ZIPPERMAN FOR STATE SENATE

PRESCOTT, ARIZONA -- After being endorsed by the Arizona Free Enterprise Club, Representative John Fillmore, and Trump-backed Kari Lake, Steve Zipperman announces another endorsement from Arizona Corporation Commissioner, Jim O'Connor.
